FOIA 24-58887-F requested all footage, including outtakes and rushes, filmed during President Obama's visit to the headquarters of the FBI on April 28, 2009.

This FOIA primarily contains footage of President Obama delivering remarks to FBI employees in the outdoor courtyard of the FBI headquarters.

System of Arrangement

The materials in FOIA 24-58887-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Communications Agency.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
