Scope and Content Note

The materials in FOIA 24-23700-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 24-23700-F requested all videos and photographs containing the actor, Chadwick Boseman.

This FOIA primarily contains photographs from a workshop for the film “42” in the State Dining Room on April 2, 2013. There are also photos of First Lady Michelle Obama greeting Chadwick Boseman in the Red Room before the workshop.

Audiovisual records proposed for opening includes video footage from the above film workshop. There is also footage from the screening of “42” at the White House on April 2, 2013.

System of Arrangement

The materials in FOIA 24-23700-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas Obama Presidential Electronic Records and White House Communications Agency.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
