Access

Scope and Content Note

The materials in FOIA 25-41154-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 25-41154-F requested all images and videos taken in the summer of 2013 when President Obama met with all the White House summer interns. President Obama met with the intern group on August 8, 2013.

This FOIA primarily contains photographs of President Obama meeting and taking group photos with both the intern leaders and the whole intern group.

There is also video footage of President Obama meeting with both groups.

System of Arrangement

The materials in FOIA 25-41154-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Presidential Electronic Records and White House Communications Agency.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama

administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
