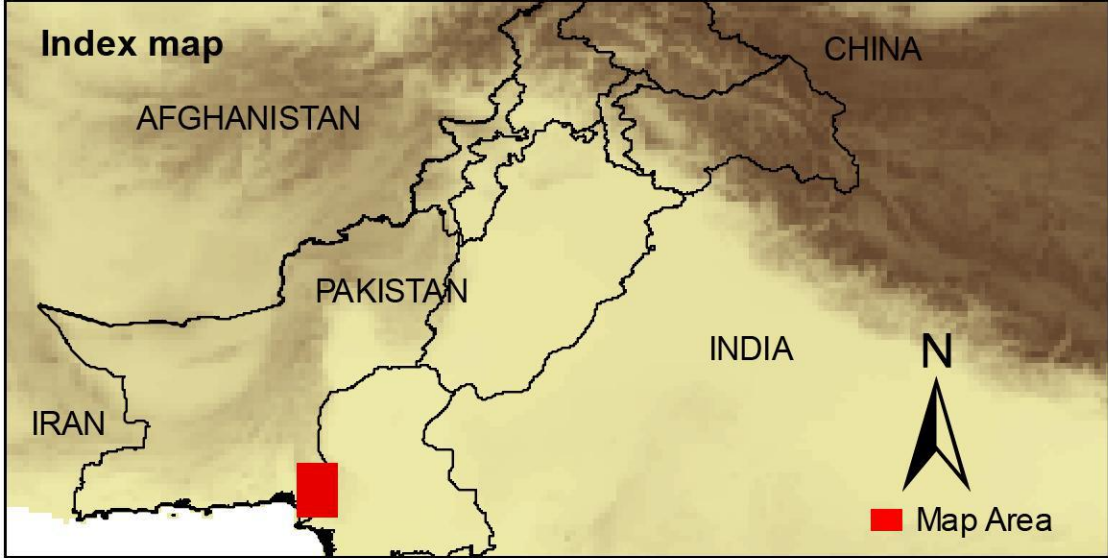

This map shows daily variation in flood water extent along the Indus rivers in parts of Sindh provinces based on MODIS Terra datasets from August 27 - 29 and September 1, 2010.

Floodwaters released from a breach at Kot Almo embankment are now heading towards coastal towns of Jati and Chuhar Jamali, in Shah Bandar, after inundating south of Sujawal town and most parts of Mirpur Bathoro tehsil. Approx. 325 sq.kms of flood waters has inundated several villages and cropland areas as observed on September 1, 2010.

Forty per cent of the population in Jati and 20 per cent in Shah Bundar have been evacuated. About 65 per cent area of the two talukas, with a combined population of 275,000, has been inundated. With all roads being under water, Sujawal has been cut off from the rest of the province. [Dawn Source]

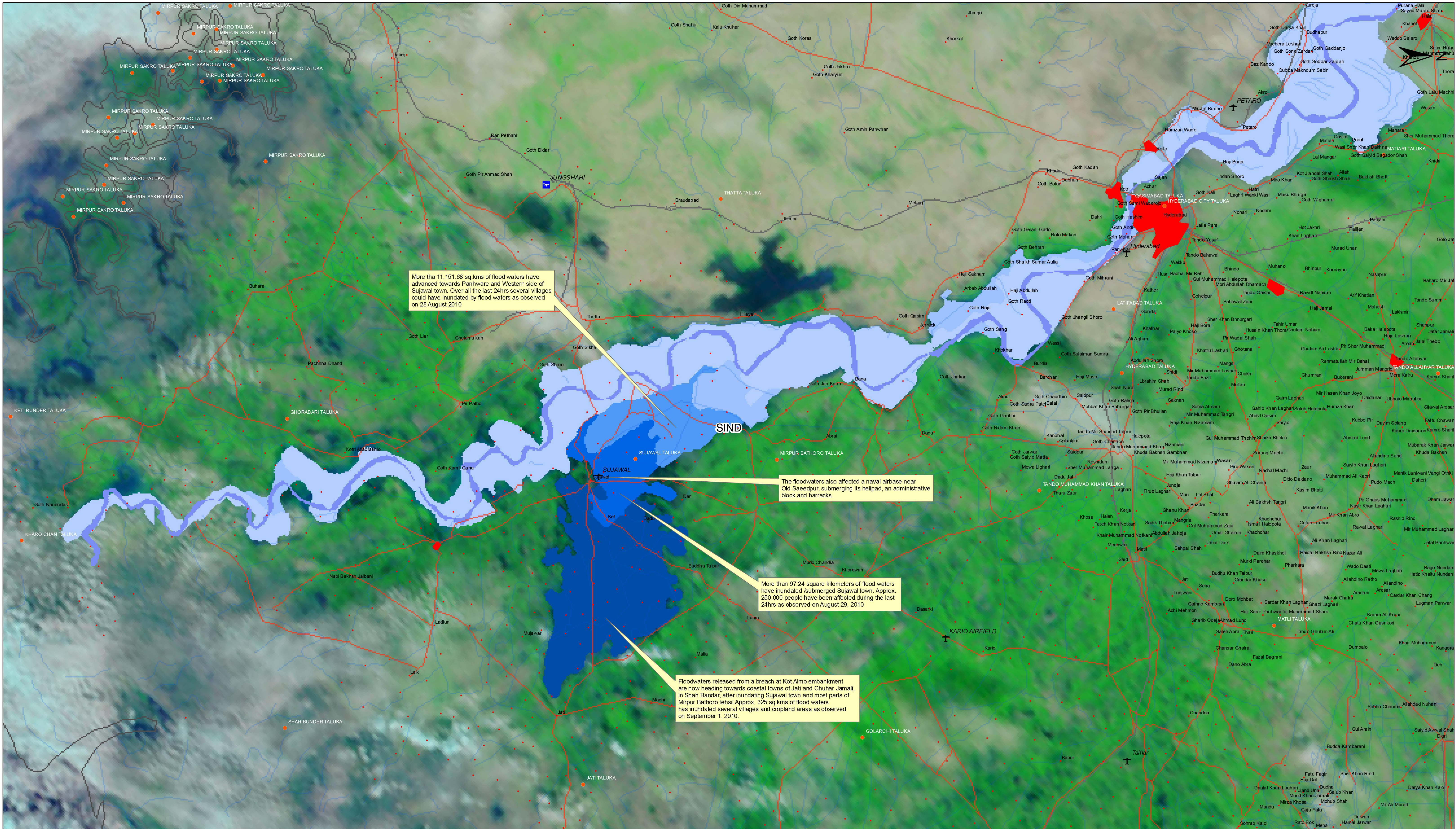

**Thai Ambassador presents cheques to Minister of State**

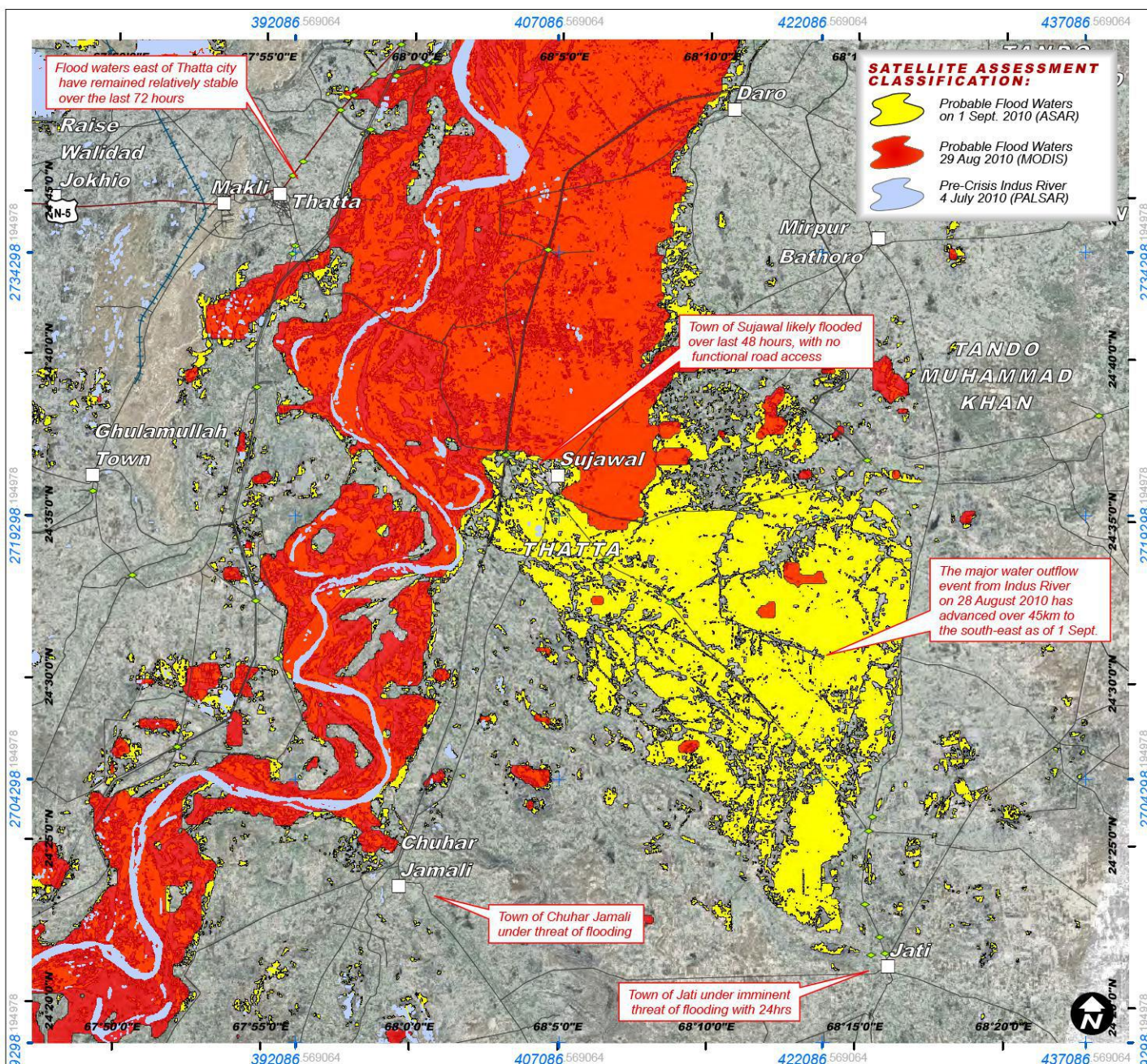
## SITUATION UPDATE 5: SUJAWAL TOWN FLOODED IN MAJOR OUTFLOW FROM INDUS, THATTA DISTRICT

**Analysis Based on ENVISAT ASAR Satellite Data Recorded 1 September 2010 (5:33 UTC)**

This is the fifth situational update on the status of flood waters between the cities of Thatta and Sujawal, in Thatta district based on an analysis of ENVISAT ASAR satellite data recorded 1 September 2010 at 5:33 UTC. Over the last 48 hours the Town of Sujawal has likely been severely flooded, with no functional road access. This was the direct result of a major water outflow event from the eastern bank of the Indus

River on 28 August 2010, advancing over 45km to the south-east as of 1 September. The town of Jati is under imminent threat of flooding within the next 24 hours. The current direction of this outflow should take it into the delta, which could act to lessen the severity of flooding further south in Thatta District along the Indus channel to the Arabian Sea. Flood waters immediately east of Thatta city have remained relatively

stable over the last 72 hours and have not advanced closer to the city. The town of Chuahar Jamali is also at high flood risk. This situational analysis is based on a rapid analysis of current satellite data available and will be revised and updated as new data becomes available; this analysis has not yet been validated in the field. **Foreign Minister visits Doha, Qatar**

Foreign Minister Makhdoom Shah Mahmood Qureshi called on His Highness the Emir Sheikh Hamad bin Khalifa al-Thani and held meetings with the Prime Minister and Foreign Minister of Qatar Sheikh Hamad bin Jasim bin Jabor al-Thani and Minister for International Cooperation and Trade and GCC Affairs Khalid Mohammad Abdullah al-Attiyah on 1st September 2010. He briefed them on the flood situation and thanked Qatar for its rapid response of sending urgent humanitarian relief assistance to Pakistan. He delivered a special message from the President to the Emir conveying gratitude for Qatar's generous and timely assistance for the flood affected people.

Foreign Minister Qureshi conveyed to the Qatari leadership that Pakistan was keen to further enhance and expand its existing friendly relations with Qatar in a number of fields. He added that Pakistan offered investment friendly opportunities which the businessmen and investors from Qatar could avail. He further said that Pakistan could provide skilled manpower to Qatar.

The Qatari leadership expressed deep sorrow over the damages caused by the devastating flood in Pakistan. The Emir assured the Foreign Minister that his country would extend all possible assistance to the brotherly country in overcoming this difficult phase in its history and would cooperate with it in the rehabilitation and reconstruction in the flood affected areas. He said that Qatar



considered Pakistan to be an important country and wished to see it economically strong and prosperous. He expressed his warm sentiments and keen desire for strengthening Qatar's relations with Pakistan.

The Prime Minister of Qatar said that he would soon visit Pakistan to coordinate efforts for further strengthening the existing bilateral relations and exploring possibilities for enhanced trade and investment between the two countries.

Foreign Minister Qureshi and Minister for International Cooperation and Trade Mr. Attiyah discussed bilateral trade and investment opportunities in Pakistan and emphasized the importance of increased interaction between the two countries.

The Foreign Minister also addressed the Pakistani community urging them to generously donate for the flood affected people in Pakistan. He appreciated the valuable contribution made by the community towards the flood relief efforts.

The Foreign Minister is visiting Qatar from 1-2 September on the last leg of his tour to Gulf region.

## **U.S. Provides Additional Flood Assistance in Sindh**

*Islamabad, September 2, 2010* – The U.S. is providing nearly \$2 million to a local partner to address the emergency needs of flood-displaced residents in Ghotki, Khairpur, and Thatta districts in Sindh.

The money will be used to help approximately 49,000 families in these flood-affected districts through the distribution of emergency shelter kits, household items, and family hygiene kits. The money will also be used to provide access to clean drinking water.

The emergency shelter kits consist of plastic sheeting, floor mats and rope. The household kits contain items such as cooking sets, battery powered lamps and a padlock. The family hygiene kits provide personal hygiene items sufficient for two to three weeks for a family of seven. Finally, the additional funding will go toward the emplacement of water tankers that will help provide potable water for the 49,000 families for 90 days.

The United States has provided more than \$200 million in emergency humanitarian assistance to the people of Pakistan to date. In support of the Government of Pakistan, the current U.S. flood relief priorities are to reach those in inaccessible areas and provide them aid, assure the current flood emergency is not compounded by a health crisis, and utilize all appropriate United States government relief resources efficiently and effectively.
